

UPDATE FROM AMHO - OCTOBER 2023

On the 5th October the **South East Queensland Seniors Forum** was held at the Brisbane Convention Centre, invitations sent out as a personal email by **COTA** (**Council on the Ageing**) **Queensland** and the **Department of Child Safety, Seniors and Disability Services**. Your AMHO Secretary attended in the room, with over 500 people watching online. It was a great day with the Minister for Seniors and Disability Services Craig Crawford in attendance for the full day.

There were many organisations all wanting to assist "those who are ageing" and we were told to "reimagine ageing" by Bernard Salt who seemed to believe we were all "cashed up baby boomers." UPDATE -

When we met with the Minister for Housing earlier this year, we were advised that by the end of October the Government would be making a decision on changes to *The Manufactured Homes* (Residential Parks) Act 2003 (the Act). To date we have not been able to confirm whether these changes will be because of the feedback provided to government by a Consultation – Regulatory Impact Statement (C-RIS) or whether they are the urgent changes we have been highlighting over the past twenty months to all members of government, and, as a result of lobbying by a small Working Group led by Bruce Saunders (Maryborough) and including The Honourable Mark Ryan (Morayfield), Chris Whiting (Bancroft) and Shane King (Kurwongbah).

You will know that over the last twenty months, AMHO has engaged with Members of Parliament to provide them with evidence of the ineffectiveness, lack of clarity and, indeed, the complete failure of this poorly worded Act to do what it is supposed to do – provide protection for homeowners. It is imperative that we are able to find some relief to the present situation which, despite being assured that there is protection by legislation to homeowners living under this Act, there is not. It is important to advise your Member of Parliament of your experiences living under the present Act if the changes are to occur - remember it is your MP who will be voting on what changes are made to the Legislation and your information can affect decisions made.

There are many problems with the current legislation which is heavily biased in favour of the park owner despite the fact that the homeowner bears all the risk – this was pointed out by government (yes, they know this) in the C-RIS. It is uncertain how, knowing and having evidence of the problems with the Act, government thought the options they presented would provide a more balanced approach.
