President's Message

Welcome to our July update!

What's happening? Well, most importantly, Carol and I were *invited* to meet with the Honourable Meaghan Scanlon, Minister for Housing, her Senior Advisor, David Greene, and other senior government officials. Although the meeting was short, it was very productive. The Minister is very aware of the issues faced by the tens of thousands of homeowners in residential parks. And what an achievement for AMHO that in just eighteen months, we are recognised as a peak body, but one which the Minister wants to engage with.

We do know that there has been work going on behind the scenes led by the member for Maryborough, Bruce Saunders to protect homeowners in the short-term eg a cap on rents, removal of the Market Review, and the establishment of an independent body to manage disputes to move away from QCAT (no lawyers and short time-lines). Although the minister would not confirm exactly what progress has been made, she did confirm that there would be change in the fourth quarter of 2023. We are uncertain whether this will be as a result of the representations by her own party or whether there is already a clear understanding of the thoughts of homeowners and other interested parties.

We've come a long way, but there is still so much to do. However, we babyboomers have changed the world by not accepting the status quo by continuing to raise the bar to make things better, so let's work together to ensure that this excellent housing model remains sustainable and that we can continue to enjoy the lifestyle we have chosen.
